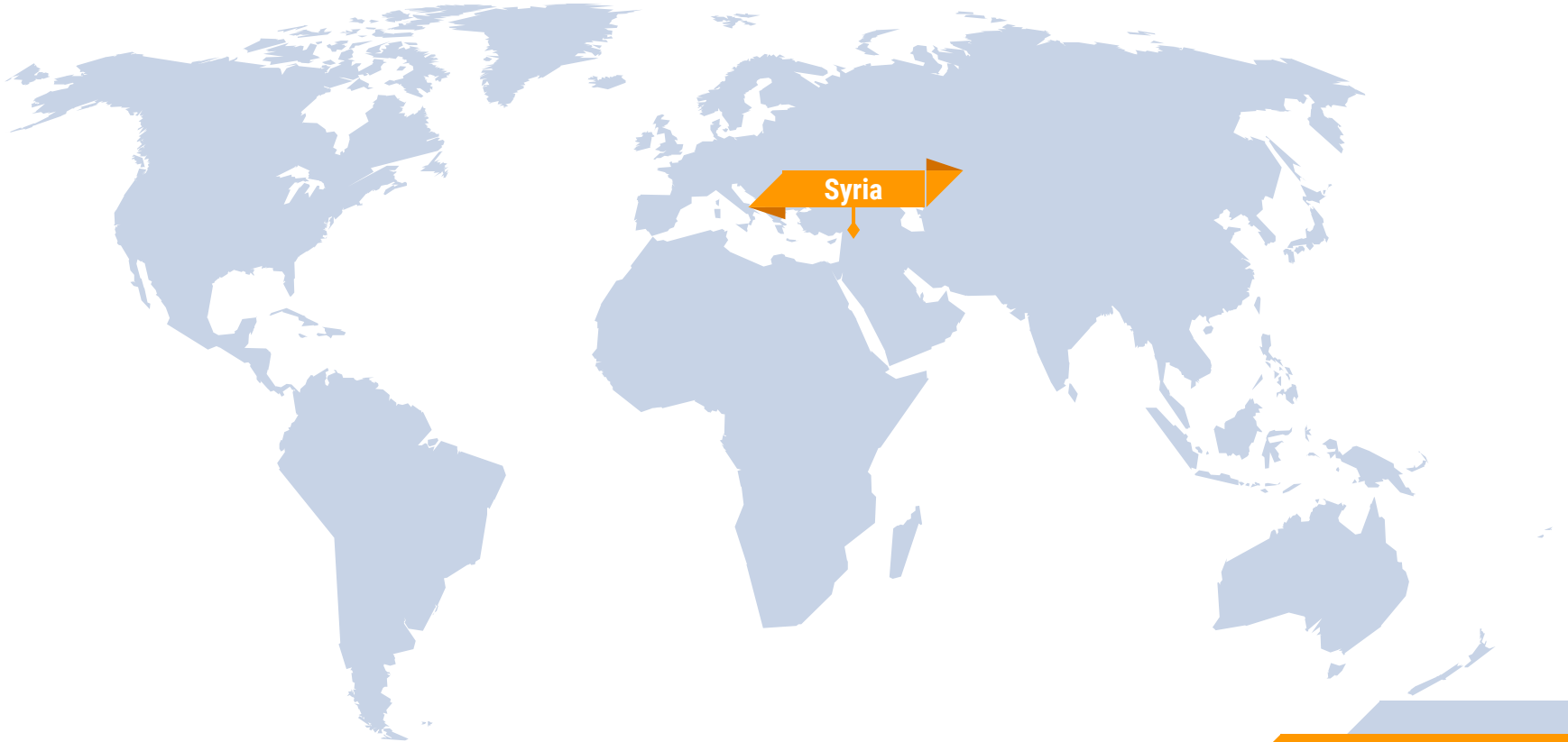


What is a policy statement?

Policy Statement is

- an official document that briefly and clearly explains how your country views a certain problem, what previous experience of dealing with that sort of problems was, and what solutions your country is willing to offer.

Example country – Syria





What is the structure of policy statement?

- Delegation: Syrian Arab Republic
- Committee: Environmental
- Question of: *assessing genetic engineering regarding its consequences for agriculture and nutrition*

You are representing not your opinion but the official position of the country



Three main questions of Policy statement

- What is the background of your country in regard to the problem?
- How does your country treat the issue currently?
- What does your country want to achieve in regard to the issue?



Paragraph #1

Try to state laconically how your country views a certain. You should no be extremely specific, but show that your country gravely addresses the issue

- The Syrian Arab Republic **considers** genetic engineering as one of the most **significant ways to prevent** famine and the lack of food in arid regions with infertile soil. **Despite** the civil war, Syria **discusses** the possibility of developing genetic engineering in order to develop intractable lands of the country (such as South-eastern part, Syrian Desert) for the cultivation of wheat, barley and other agricultural products. **Moreover**, systematically correct development of genetic engineering allows the country to receive humanitarian aid not only in the form of products, but also in the form of crops adapted to the conditions of the Syrian environment.



Paragraph #2

Possible solutions to solve the problem (try to be creative and realistic and the same time)

The main goal of our government is **to ensure all possible actions to stimulate the development** of genetic engineering with countries, providing us with support in the form of humanitarian assistance and assistance in the political arena. The Syrian state considers the following methods that can promote the development of genetic engineering:

- Promoting the development of associations and joint work of farmers and scientific institutions of genetic engineering,
- Encourage the development of genetic engineering by the state, through the provision of various forms of support,



Paragraph #3

The government of Syria is **fully confident** that the future of agricultural development is behind genetic engineering and selection, which will **eliminate food problems** in the foreseeable future.

Order of the debates

- Introduction of chairs
- Roll-call
- Chair calls the main-submitter of the resolution to read out the operative clauses
- Chair sets the debate time/debate mode
- Main-submitter delivers his speech and after that answers points of information
- Debates start (Nations take the floor and deliver their speeches or propose amendments)
- Voting on the resolution



Debate time/mode

- **Closed debates**
- In the first part of the debates only nations in favor of the resolution/amendment can take the floor. In the second part – only those nations that are against (ex. 30 min. in favor, 30 min. against)
- **Open debates**
- Any nation wishing to speak either in favor or against the resolution may take the floor (ex. 1 h 30 min of open debates)



Points

Point of Personal Privilege:

- Refers to the comfort and well-being of the delegate,
- May only interrupt a speaker if it refers to audibility,
- Is not debatable
- Does not require a second

Point of Order

Refers to procedural matters only, i.e. if the chair makes an error in the order of debate or in the setting of debate time

Point of information to the speaker (A question directed to the delegate having the floor):

- Must be formulated in the form of a question, i.e. "Is the speaker aware that."
- Only ONE question by the same questioner. There will be no dialogue between speaker and questioner on the floor



Points

Right to follow up

The delegate may use this point if he is not satisfied with the answer

Point of Information to the Chair:

- A question to the chair,
- May not interrupt a speaker,
- Can refer to almost anything, from issues to personal priorities

Point of Parliamentary Enquiry:

- Point of information to the chair concerning Rules of Procedures,
- Example: "Could the Chair please explain to the house what is meant by closed debate?"

Motions

"Motion to move to the previous question"

- ❑ *During open debates* calls for the closure of debate and vote,
- ❑ *During closed debates* calls for moving into the time against;

"Motion adjourn the debate":

- ❑ Calls for the temporary disposal of a resolution,
- ❑ Practically means the death of the resolution if there is a lack of time



Motions

"Motion to reconsider a resolution"

Calls for a re-debate and re-vote of a motion that has already been discussed (adopted or rejected)

"Motion to extend debate time"

Calls for extension of the debates

"Motion to divide the house"

roll-call vote; may be used in case of arguable results of the previous voting procedure



Final questions

Imagine that you are losing consciousness during the debates. What point will you use?

Chair said that the time in favor of the amendment has elapsed but you have a speech in favor. What are you going to do?

What's the difference between the Point of order and the Point of Parliamentary Enquiry?

The house has just voted on the resolution – 25 votes in favor and 27 against. You think that the votes haven't been counted right. What motion will you use?
