

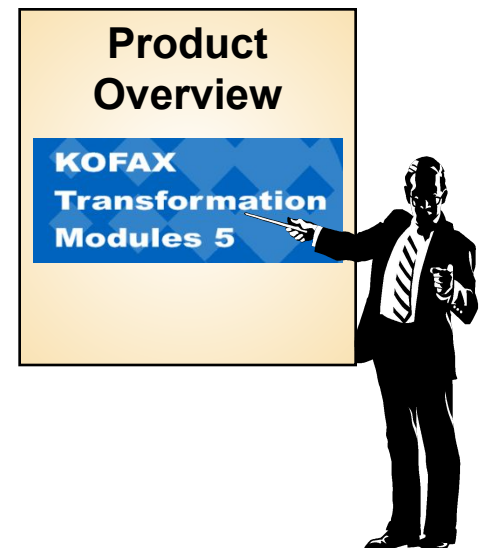

What is KTM?

- KTM is a classification, separation and extraction “transformation” product for Kofax Capture (a suite of custom module add-ons)
- Although somewhat new to Kofax Capture, the product was introduced as Ascent Xtrata Pro 3.0. The product has now been rebranded as Kofax Transformation Modules, and this version is a 5.x release.
- Supports classification and extraction of structured, semi-structured and unstructured documents.
- Platform for delivering pre-configured, out-of-the-box solutions
- Offers learn-by-example extraction as well as numerous other methods to automatically extract data from documents
- Invoice classification by image and instructions (rules).

Structured or Unstructured?

- KTM – Includes processing modules, a configuration application and several tools that work within Kofax Capture providing advanced document classification, separation, and extraction for structured, semi-structured and unstructured documents. It is optimized for invoice processing.

1. BORROWER'S PROMISE TO PAY
I, the undersigned, for a loan that I have received, I promise to pay U.S. \$ ****131,920.00 (this amount is called "Principal"), plus interest, to the order of the Lender. The Lender is GREENBRIDGE MORTGAGE SERVICES, LLC.

I will make all payments under this Note in the form of cash, check or money order.

I understand that the Lender may transfer this Note. The Lender or anyone who takes this Note by transfer and who is entitled to receive payments under this Note is called the "Note Holder."

2. INTEREST
Interest will be charged on unpaid principal until the full amount of Principal has been paid. I will pay interest at a yearly rate of 5.250%.

Definitions

- **Classification** – Distinguishing between different Document Types and Form Types.

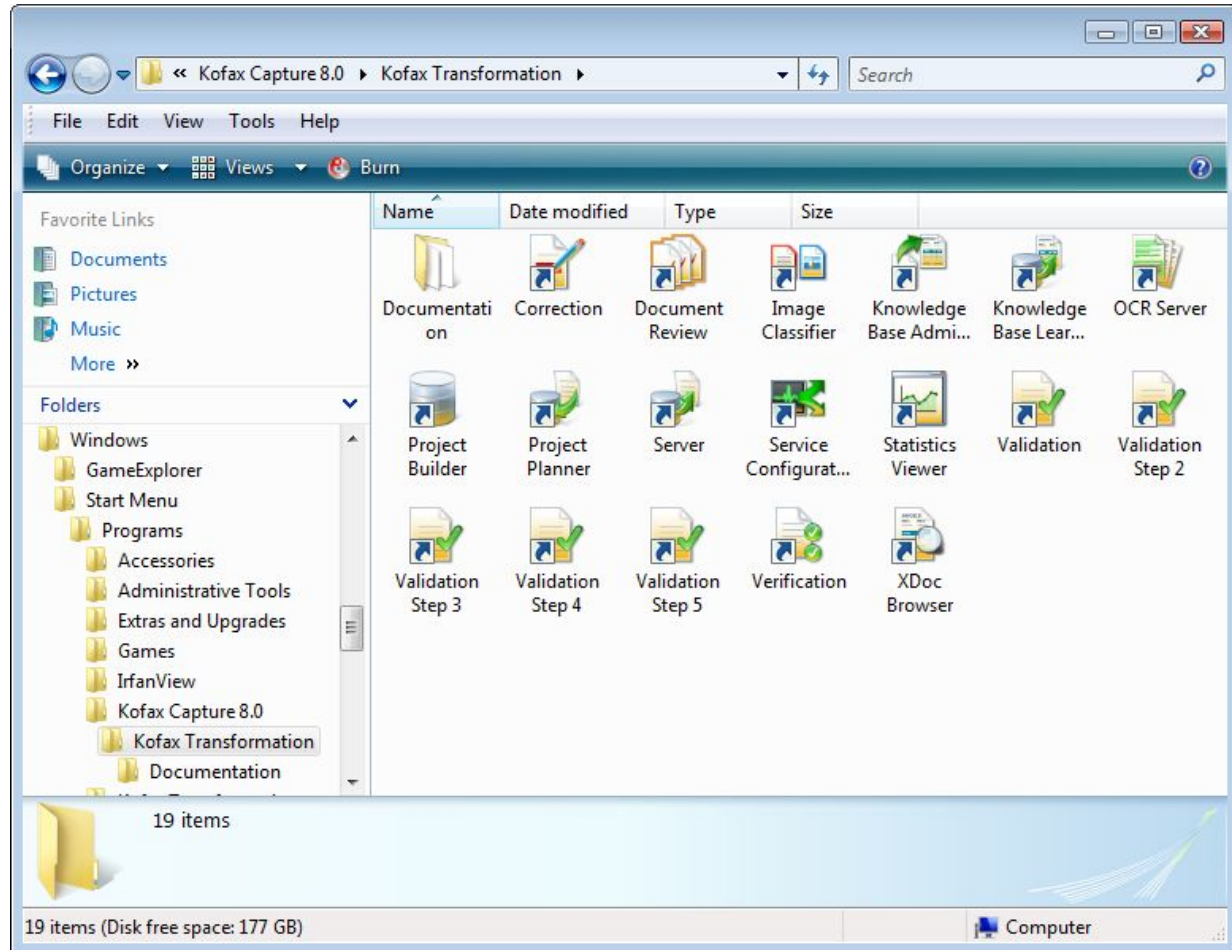

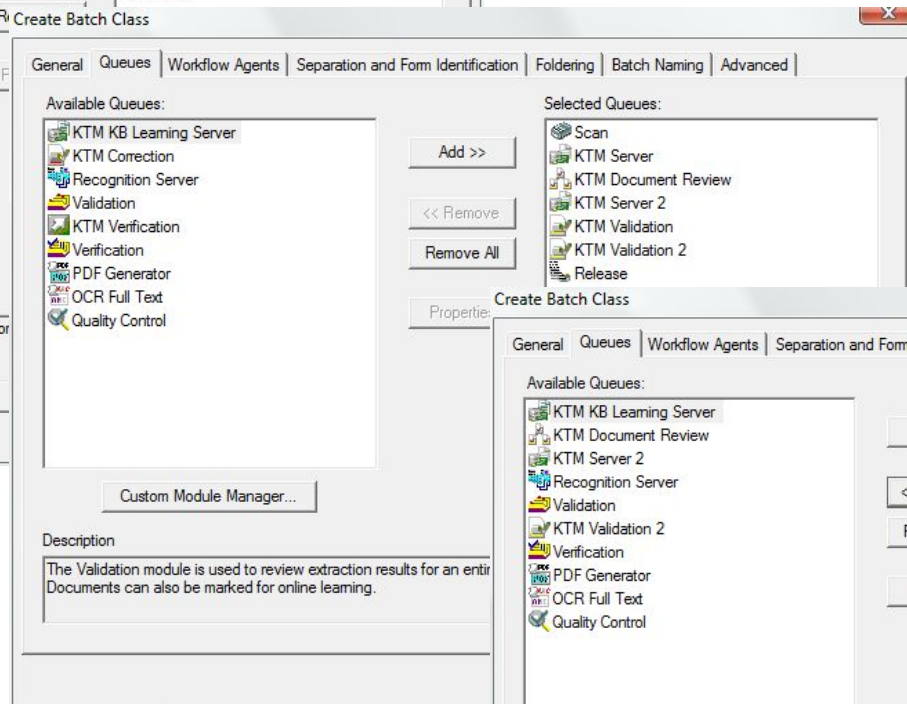

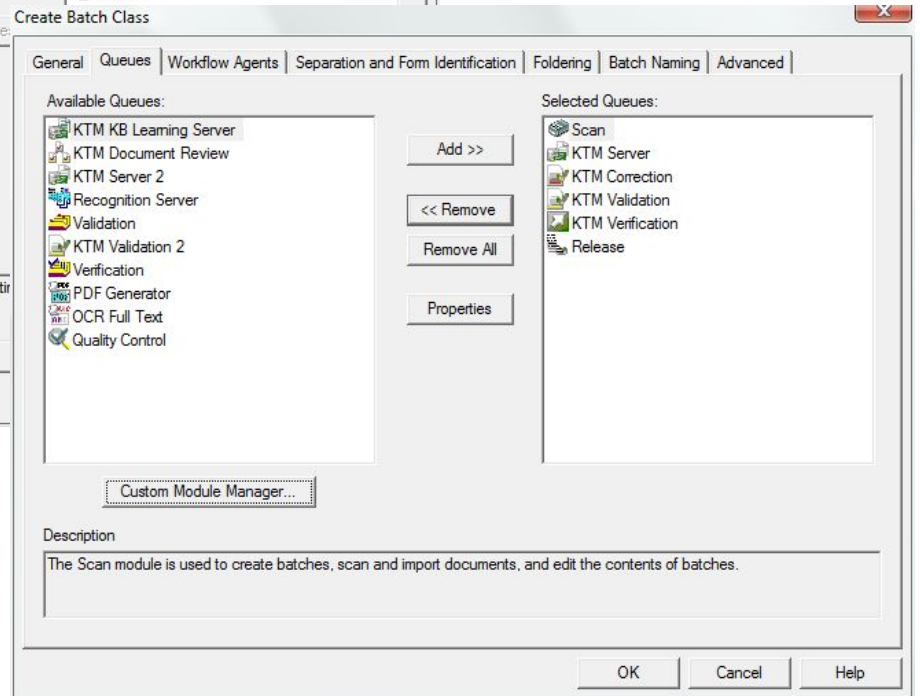
