Legal Status of the Government of the Russian Federation. 6 of the Constitution of the Russian Federation (Articles 110 - 117) and the Federal Constitutional Law "On the Government of the Russian Federation". In accordance with Art. 110 of the Constitution of the Russian Federation Federal Service for Supervision of Compliance with the Legislation of the Russian Federation, and according to Art. 1 of the Federal Constitutional Law "On Federal Authorities The Government of the Russian Federation is the supreme executive body of state power of the Russian Federation. The Government of the Russian Federation is a collegial body that heads a unified system of executive power in the Russian Federation.

The government acts in accordance with the provisions of the President of the Russian Federation and grants its powers to the newly elected President of the Russian Federation. The government can resign, where it is accepted or rejected by the President. The President himself can decide on the resignation of the Government. The State Duma can express a lack of confidence in the Government, on the basis of which the President has the right to announce the resignation of the Government, or disagree with the decision of the State Duma. Re-expression of distrust by the Government, or dissolve the State Duma.

The Government of the Russian Federation consists of members of the Government: the Government, the Government and the Government of the Russian Federation. In cases, the Constitutional Party of the Russian Federation, the Chairman of the Government of the Russian Federation temporarily performs the duties of the President of the Russian Federation. In case of inopportunement of its execution, the Government of his duties is performed by one of his deputies in accordance with the written distribution of duties. The Chairman of the Government of the Russian Federation appoints and dismisses the President of the Russian Federation in the manner established by the Constitution of the Russian Federation. The dismissal of the Chairman of the Government simultaneously entails the resignation of the Government. Possession of the Russian Federation can be resigned if it is accepted or rejected by the President of the Russian Federation.

Powers RF:

The Government of the Russian Federation directs the work of federal ministries and other federal executive bodies and monitors their activities, they, in turn, submit to the Government and are responsible for their implementation.

The Government of the Russian Federation may, in order to exercise its powers, establish its territorial bodies and appoint appropriate officials.

The Government of the Russian Federation has the right to revoke acts of federal executive bodies or to suspend the acts of these acts.

The government, within its powers: organizes the country's domestic and foreign policies; Implementation of regulation in the socio-economic sphere; Ensures the unity of the executive power system in the Russian Federation, directs and controls the activities of its bodies; Forms federal targeted programs and ensures their implementation; Realizes the right of legislative initiative granted to him. He can make decisions with respect to some of his powers, if this does not contradict the Constitution of the Russian Federation and federal laws. At the same time, the Government exercises the powers delegated to it by the executive authorities on the basis of relevant agreements.

In the sphere of economy, the Government of the Russian Federation: ensures the unity of economic space and freedom of economic activity, the free movement of goods, services and financial resources; Forecasts the socio-economic development of the country; Develops and implements the state policy in the sphere of international, investment cooperation.

In the sphere of budgetary, financial, credit and monetary policy, the Government of the Russian Federation: ensures its unity in the country; Develops and submits to the State Duma a federal budget and ensures its execution, as well as a report on its implementation; Develops and implements tax policy; Ensures the improvement of the budget system; Takes measures to regulate the securities market; Manages monetary and financial activities in the relations of the Russian Federation with foreign states; Develops and conducts measures to conduct a unified price policy.

In the social sphere, the Government of the Russian Federation: ensures the implementation of a unified state social policy in this area, the exercise of labor rights and citizens' rights for social security, and the implementation of a unified migration policy; Takes measures to



In the field of science, culture and education, the Government of the Russian Federation ensures: state support of fundamental and priority areas of applied science; Implementation of the unified state policy in the field of education; Support of culture and preservation of the country's cultural heritage.

In the field of environmental protection, the Government of the Russian Federation: ensures the implementation of a unified policy in this area, in particular, on environmental safety; Measures are being taken to implement the citizens' rights to a favorable environment; Measures for the conservation and rational use of natural resources have been organized; Coordinated measures to prevent natural disasters, accidents and disasters, eliminate their consequences, etc.

In the sphere of ensuring legality, rights and freedoms of citizens, combating crime, the Government of the Russian Federation: participates in the development and implementation of state policy in the field of ensuring the security of the individual, society and the state; It implements measures to ensure the legality, rights and freedoms of citizens, the protection of property and public order, the fight against crime and other socially dangerous phenomena.

In the sphere of defense and state security, the Government of the Russian Federation: all necessary measures are taken in this area; The Armed Forces are equipped with weapons and military equipment; Social guarantees are provided to servicemen; Measures are being taken to protect the state border; The Civil Defense Department is carried out.

In the sphere of foreign policy and international relations, the Government of the Russian Federation: implements measures to implement the country's foreign policy; Concludes international treaties and ensures their implementation; Carries out regulation and state control in the sphere of foreign economic activity.
