RIGHTS - ARE YOU AWARE OF YOUR RIGHTS?

- to live (obvious but important)
- to choose your own religion
- to an education
- to be with you parents
- to be protected from abuse and neglect
- to express the views you have
- to a decent standard of living
- to choose your friends and hang out with them
- to be protected from all forms of cruelty, exploitation and torture.
